The chairman briefed the activities to be taken by the board for implementation during the year 2018-2019. The following actions are implemented based on the feedbacks collected from all the stakeholders.

ITEM 1 :

To approve the rules, regulations and syllabi for the students admitted in B.Sc CT during the academic year 2018-2019.

- a) Outcome based Education (OBE) Syllabi has been framed and discussed in the board for the B.Sc Computer Technology students to be admitted from the academic year 2018-2019 & Onwards. The chairman presented the details of the curriculum, syllabi and scheme of examinations prescribed for B.Sc Computer Technology course. The board suggested the following changes in the syllabi prescribed for B.Sc Computer Technology course for the academic year 2018-2019.
- (i) To revise the practical list for Core practical 4 - Visual Basic .NET and Oracle lab in Semester IV
 - (ii) In Semester IV, the practical list for Skill based subject 2 - Computer Installation and Servicing lab has been revised.
 - (iii) In Semester V, to revise the core paper 10 - Software Engineering and Testing
 - (iv) To revamp the practical list for the core practical 5 - Software Testing lab in Semester V
 - (v) To introduce the Non-Major Elective paper Consumer Affairs.
- b) The board approved the above curriculum, syllabi and scheme of examinations pertaining to B.Sc CT & students admitted during the academic year 2018-2019

ITEM 2 :

The Skill based subjects for the students admitted in the academic year 2016-2017 is ratified as follows:
