The chairman welcomed the Information Technology Board members for the implementation of the syllabus during the academic year 2014-2015. The chairman then requested the members to take-up the agenda for discussion and approval.

The chairman briefed the activities to be taken up by the board for the implementation during the year 2014-2015. Based on the Feedback collected from the stakeholders the following changes have been carried out.

Item 1:

To Approve the rules, regulations and syllabi for the students admitted in B.Sc IT during the academic year 2014-2015.

- a) New syllabi have been framed and discussed in the board. The chairman presented the details of the curriculum syllabi and scheme of examinations prescribed for B.Sc IT Course. The board suggested the following changes in the syllabus prescribed for B.Sc IT Course for the academic year 2014-2015.

Semester - I.

(i) The core paper - I "Data Structures and C programming" is renamed as "Computing fundamentals and C programming" and the syllabus is framed accordingly.

(ii) To change the practical paper "Programming Lab C and Data Structures" as "programming Lab-C" and to change the practical list accordingly.

Semester II

(i) To revise the syllabus for core paper II Computer Organization and Architecture.

Semester III

(i) To include a new Core Paper "Data Structures and algorithms".

Semester IV

(i) To replace the paper Software Engineering with Operating System.

Semester V

(i) To include a new Core paper "Open Source Tools" instead of core paper xi - "Web Technology".

(ii) To rename the practical paper "programming Lab - web Technology" as "programming Lab - PHP" and to change the list accordingly.

Semester VI

(i) To change the core paper Software Testing as Software Engineering.

Elective Papers :

(i) To revise the syllabus for Elective I Embedded system

(ii) To revise the syllabus for the Elective II Data Mining and to prescribe a new text book.

(iii) To introduce a new Core paper "Information Security" instead of Elective III.

The board approved the above Curricular syllabi and scheme of examination pertaining to B.Sc IT and the students admitted during the academic year 2014 - 2015.

b) The board considered and approved the curriculum, syllabi and scheme of examinations for the allied papers.


Item 2: To suggest a panel of Question paper setters.
