**WHEREAS** Alpha Pegasus LabTech Solution (APLTS) is a new emerging company with its registered (TN03A0067318) under National Industry Classification (NIC) code of NIC 2 digit – 20 , NIC 4 digit – 2023 and NIC 5 digit – 20232. 5. However, any point of time Party-2 help and suggestions are considered by Party-1 to develop its business activities after mutual agreement between both parties authorized persons.
6. Party-2 developed own products may promoted and Marketed by Party-1 at the sole discretion of Party-2 after evaluation, certification and agreement between both parties authorized persons.
